 - iii. Working on getting a contract lined up with the Department of Commerce for 5% match finding with CDBG-DR funds from HUD.

- a. Gavin provided an adjudication update.
 - SB 5212, which would allow pre-code water users without a statement of claim to file in the adjudication, is on the Senate's consent calendar, and will likely see floor action within the next few weeks.
- b. Fred will be organizing a water rights education session for landowners in March or April.

- b. Moorlag Ditch field flooded. Does not seem to be related to the creek.
